



RENTAL AGREEMENT FOR COMMERCIAL USE OF INFLATABLES

It is the SOLE responsibility of the person or organization hiring this inflatable equipment to ensure that every precaution is taken. Public/Commercial use inflatables must be supervised at all times by an attendant supplied by the person or organization hiring the inflatable.

RULES & REGULATIONS

1) No food, drinks or chewing gum on or around the inflatable at any time. This will avoid a choking risk and keep the unit clean.

DIRTY CONDITION: If there is grass, leaves, water, mud, or ANYTHING ELSE on the castle, if it isn't returned in the condition it was received in, it will be considered dirty. Only water and a soft cloth are to be used when cleaning the inflatable unit.

CLEANING PRODUCTS/CHEMICALS MUST NEVER BE USED.

You **MUST** first deflate the unit, then clean/sweep/wipe it down with water. Shoes must be removed when cleaning.

2) Shoes, glasses, jewelry, and badges **MUST** be removed before using the inflatable to avoid injury and damage. Failure to follow this rule will incur a \$80.00 damage charge.

3) No face paints, party poppers, colored streamers or silly string near the inflatable (within 250 feet). These products will be removed at the discretion of the attendant.

4) Absolutely **NO SMOKING** on or around the inflatable at any time.

5) Climbing, hanging, or sitting on walls is dangerous and **NOT ALLOWED AT ANY TIME.**

6) An adult must supervise the inflatable **AT ALL TIMES.**
An adult **MUST** also supervise setup and takedown.

7) Children **MUST NOT** push, collide, fight, or behave in a way that could cause injury.

8) Absolutely no pets, toys, or sharp objects on the inflatable.
Failure to follow this rule will incur a \$100.00 damage penalty.

9) No one is allowed on the inflatable during **INFLATION** or **DEFLATION** — this is **DANGEROUS.**

10) Children MUST NOT attempt somersaults or acrobatics and must be properly clothed.

11) If the blower stops working:

All users MUST get off immediately

Check fuses and tubes for blockage

If overheating or power loss occurs, turn blower off and restart after 1–2 minutes

If it does not restart, contact immediately 204-228-4260

12) In the event of rain:

The inflatable MUST be deflated

Use during rain is unsafe and NOT permitted

The blower must be stored in a dry place

Failure to unplug during rain may cause electric shock

During rain, the inflatable becomes VERY slippery and unsafe for use.

Failure to follow these rules could result in serious injury.

13) The inflatable(s) must not be used when wind speeds exceed 15 mph / 24 km/h, as the unit can be blown away with

14) The unit MUST NEVER be dragged or set up on rough surfaces (asphalt, concrete, gravel, etc.).

The setup area must be cleared of anything that could puncture or damage the inflatable.

Failure to follow this rule will result in damage charges.

LIABILITY DISCLAIMER

1) This rental equipment has been received in good condition and must be returned in the same condition.

You have been informed of safety instructions, proper inflation/deflation, and risks.

Additional charges may apply if returned damaged or dirty.

2) The customer assumes all responsibility for injuries or property damage and agrees to release BU EVENTS AND RENTALS

3) If any part of this agreement is unenforceable, liability is limited to the total rental amount paid.

4) The company has the right to enter the premises at any time to repossess equipment.

5) Equipment must not be loaned, sublet, or used at another location.

6) Customer agrees to pay full replacement cost (including labor) for any damages.

7) If equipment is lost, stolen, or damaged beyond repair, the renter agrees to pay full replacement cost immediately.

Invoices will be provided for transparency.

The renter agrees that BU EVENTS AND RENTALS will not be held liable for any injury or damage.

I have read the above agreement and fully understand and accept all conditions.

I understand that I am fully responsible for the inflatable while in my care and agree to pay for any damages.

I agree to pay a \$80 cleaning fee if the inflatable is returned dirty.

Security Deposit will be return after 24-48 business hours.
